### NEW SYSTEM for E.E.I.C.

Important new step: Once registered, PENNDOT requires students to purchase an exam package from the PA Training Portal website ([www.patrainportal.com](http://www.patrainportal.com)). The package consists of training materials and two exam attempts. The cost of this package is \$39.99, payable via credit or debit card. Students may purchase as soon as they are registered OR on the first night of class.

Requirements: Manual included - 100% attendance required.

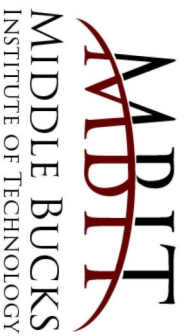
