

## PA Criminal Record Check – Act 34

You can accomplish the PA Criminal Record check in <u>one</u> of the following two ways:

 Fill out Part I of the Pennsylvania State Police Request for Criminal Record Check Form SP -164 (attached). The form should be submitted with a money order or certified check in the amount of \$10.00 payable to *Commonwealth of Pennsylvania*. After completion mail to:

## OR

2. Order the record check on-line by logging onto <u>https://epatch.state.pa.us</u> and select "Submit a New Record Check" under credit card users. You must provide your name and address, individual information and credit card information. If a request goes "under review" it will be updated to the status of "No Record" or "Record" within two weeks. For all "No Record" responses, the certificate must be printed out at the requestor's computer. All "Record" status requests will be mailed to the address provided by the requestor. PATCH does not maintain requester and credit card information for non-registered users; therefore, this information must be entered each time a non-registered user logs onto PATCH.

\*Please Note: If you obtain your clearance on-line, please be sure to print a copy of the certificate form with the logo in the background (you must click on the link called "Certificate Form"); otherwise it is not considered official and will not be accepted as a current clearance.
