Responsibilities:

- Administer first aid and emergency medical care as needed to students and staff.
- Contact emergency responders, physicians, or parents in cases requiring additional care.
- Maintain detailed individual health records and communicate relevant health conditions (e.g., allergies, medical needs) to appropriate staff.
- Keep accurate and current medical records, emergency contact forms, and accident reports.
- Track all student referrals using a digital health log and follow up on injury recovery.
- Notify the Business Office and Director of employee injuries and initiate workers’ compensation procedures promptly.
- Assist administration in developing and implementing a comprehensive schoolwide safety program.
- Collaborate with teachers to promote lab safety protocols and personal health standards in classrooms.
- Schedule and oversee monthly emergency drills (fire, lockdown, etc.) and maintain records.
- Maintain and inspect first aid supplies and equipment regularly.
- Participate in annual lab inspections alongside the Facility Supervisor and submit safety reports with recommendations.
- Ensure school compliance with OSHA standards, ADA, and Right-to-Know regulations; advise administration on necessary updates.
- Serve as a liaison with sending district school nurses to ensure consistent student care.
