Dear Parents/Guardians:



## Use of Technology Agreement

Middle Bucks Institute of Technology will provide access to technology for students who have permission from their parent/guardian to use the network and related technology and who agree to the provisions, requirements, and prohibitions outlined in our school policy. However, access to technology and the Internet through school resources is a privilege, not a right, and may be revoked from anyone who uses these resources inappropriately, as determined by school authorities.

This policy strictly prohibits the following activities and any others determined by school authorities to be unacceptable use of technology. These prohibitions are in effect anytime during school when resources are accessed in any way, whether in the school or indirectly through another Internet service provider.

- Allowing an unauthorized person to use an assigned account;
- Use of the network or school technology for non-school related purposes;
- Use of the network or school technology to access or transmit obscene or pornographic material;
- Use of the network or school technology to access or transmit material likely to be offensive or objectionable to recipients;
- Use of the network or school technology to participate in an inappropriate and/or objectionable discussions or news groups;
- Use of the network or school technology to transmit hate mail, harassment, discriminatory remarks, and other anti-social communications;
- Use of the network or school technology to order or purchase in the name of the school or any individual for merchandise or services. All costs, to the school or any individual, incurred because of this violation will be the responsibility of the user;
- Use of the network or school technology which results in any copyright violation;
- Use of the network or school technology to access any fee-based on-line/Internet service. All costs incurred to the school or any individual will be the responsibility of the user;
- The illegal installation, distribution, reproduction or use of copyrighted software in school computers or other school technology;
- Use of the network or school technology to intentionally obtain or modify files, passwords, or data belonging to other users;
- Use of the network or school technology to misrepresent other users on the network;
- Use of the network or school technology for fraudulent copying, communications or modification of materials in violation of local, state, and federal laws;
- Loading, downloading, or use of unauthorized games, programs, files or other electronic media;
- Malicious use of the network to develop programs that harass other users or infiltrate a computer system and/or damage the software components of a computer system;
- Destruction of school computer hardware or software;
- Use of the network to participate in unauthorized Internal Relay chats (on-line real-time conversation);
- Use of the network to facilitate any illegal activity; and
- Use of the network for commercial for-profit purposes.

## Appropriate Technology Use During Virtual/Remote Learning

Middle Bucks Institute of Technology is dedicated to providing engaging, robust, and rigorous virtual learning opportunities for our students. In the event that Flexible Instructional Days need to be used, MBIT will be employing synchronous (live) and asynchronous (independent) learning modalities via a virtual platform. Prior to engaging in these virtual learning activities, MBIT seeks to clarify guidelines for appropriate technology use during virtual/remote learning activities. These are as follows:

1. MBIT strictly prohibits screenshots, pictures, audio/video recording and distribution of any virtual educational experience in order to protect student privacy and prevent cyberbullying and the distribution of copyrighted materials. Please be aware that in Pennsylvania, it is illegal to record another person through any medium without his or her consent.
2. Students, and where appropriate parents/guardians, agree to engage in a virtual learning in a quiet, private area to the extent possible given the circumstances in order to minimize background noise and distractions and to protect the integrity of student engagement as well as student confidentiality.
3. Parents/guardians and other household members who are normally not privy to the day-to-day classroom and group service discussions agree to respect and keep confidential any personal or private information that may be inadvertently discovered about other students due to proximity during virtual learning.

## Student Use of Technology Agreement

As a user of Middle Bucks Institute of Technology, I have read the policy governing access to and usage of school technology resources and agree with its terms.
